
Emissions reduction targets

Una Health has made steps to increasing the amount of hybrid cars in our fleet, with 50% hybrid in 2023. To continue our progress to achieving Net Zero we will endeavour to increase this further, with an aim to have a 100% hybrid fleet by 2041.

We project that this will decrease our fleet emissions from a projected 16.63 tCO2 without action to 9.55 tCO₂e by 2041, a decrease of 43%.







Factors in expected workforce increase in 2024-25 and 3% increase in miles every other year due to increase in workforce.

Carbon Reduction Projects

Una Health increases premise size in Stoke-on-Trent in 2024, to support expanded growth and better support our customers through enhanced warehouse and office facilities. It is therefore expected that our emissions may increase due to this, but we are putting in place initiatives to achieve our Net Zero target.

Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- In January 2024, Una Health expanded office space to accommodate company growth.
 Initiatives are in place to make the premises more energy-efficient. Examples include LED energy efficient lighting.
- Operations will endeavour to simplify and reduce upstream shipments, especially from overseas.









- Recycling projects and sustainable packaging to reduce waste. Una Health will look into more compact packaging to reduce space required during shipping.
- Recycling bins will be placed around site to encourage more recycling.
- Reducing office printing.
- Education of our workforce to participate in decarbonisation of the company.
